

Risk Assessment Questionnaire for Student Travel abroad to a Host Institution

Introduction

This questionnaire is to be filled out by students who are planning a stay abroad at a potentially risky destination during their course of studies at ETH Zurich. Based on this information, the SSHE Department can perform a risk assessment of the planned trip based on the travel destination and the activities planned on site. When filling out this questionnaire, students ought to try to state all steps and activities relevant for safety and security, as well as the associated measures to minimise risk, in order to enable SSHE to carry out as comprehensive an assessment as possible. Supervision by a host institution (university, internship company, NGO or similar) is compulsory for students. Solo work (e.g. field work) without connection to a host institution will not be approved.

This questionnaire must be filled out and submitted to SSHE for assessment for all travel abroad to destinations classified as security level 3 or 4 by the Austrian Federal Ministry of European and International Affairs (BMEIA). Travel to destinations classified as security level 5 or 6 is prohibited for students. No particular measures are necessary for travel to destinations with security level 1 or 2; the questionnaire need not be submitted to SSHE for assessment in these cases.

This questionnaire is based on the <u>Safety and Security Recommendations for Research Enterprises abroad</u> of ETH Zurich. Members of ETH Zurich can find practical safety and security tips for travel abroad in these recommendations. These guidelines should be read and the tips implemented during travel preparation.

Approval

SSHE can approve submitted travel plans. If SSHE considers the risk to be too high or the travel preparation to be insufficient, it may prohibit a trip
