



## **Consent form**

for the photo competition 'KEEP IT CO<sub>2</sub>OL' on CO<sub>2</sub> and climate change by focusTerra, ETH Zurich

Dear parent or guardian,

Your child would like to provide us with a photo they have taken and a short personal story they have written on the subject of CO<sub>2</sub> and climate change for an exhibition at ETH Zurich via submission on our website. As your child is not yet of legal age (18), we need you to sign this consent form as a parent or legal guardian. You must sign the declaration of consent <u>before</u> the photo and story are submitted. When submitting the photo and personal story, your child must also upload the signed consent form to our website. For this purpose, the consent form may be photographed or scanned. It can also be signed digitally. Upon submission, we collect the child's first name, surname, date of birth (age), email address, telephone number (optional), Instagram account (optional), location (city/village, country) where the photo was taken, title, personal story and the photo itself.

If selected by the jury, we will use your child's photo and personal story (incl. title) in the upcoming special exhibition 'KEEP IT CO<sub>2</sub>OL' at ETH Zurich. This includes the use on websites and social media channels of ETH Zurich and other exhibition venues where the exhibition will be shown at a later date (in Switzerland or abroad), as well as in the exhibition publication and on posters and brochures for science communication and advertising purposes for the exhibition (purpose of use).

focusTerra guarantees that the submitted materials will only be used for the aforementioned purpose and not for commercial purposes. The data collected will not be passed on to third parties. The first name and age of the child will be published together with the photo taken by the child, including the story and title, and used as part of the special exhibition 'KEEP IT CO<sub>2</sub>OL' at ETH Zurich and any other exhibition venues.

Please note that brands, trademarks and works of third parties may be legally protected and may not be published or depicted without the consent of the authorised parties (e.g. Eiffel Tower at night).





By entering the competition, participants confirm that they have taken the photo and written the story themselves and are the therefore author of the submitted content and have unrestricted rights of use. They also confirm that the photo submitted does not infringe the rights of third parties. Persons who can be recognised in the photo must have agreed to the publication and use of the photo by focusTerra. The senders or their legal guardians are themselves fully liable if any claims are made due to image rights (warnings, lawsuits, etc.).
