**The program on “Culture and Religion in Mediation” (CARIM) aims to improve the way conflicts with religious dimensions are dealt with. It supports actors from conflict contexts, peace practitioners and policy makers to ensure that the role of religion in conflict is better understood and addressed.**

Conflicts with religious dimensions pose a significant challenge to global peace and security. The number of such conflicts is increasing and they are also among the most difficult conflicts to resolve.

The CARIM program was created to develop and disseminate approaches to mediation that are mindful of the particular challenges that conflicts with religious dimensions pose. It offers new and more effective ways of addressing such conflicts.

CARIM is a joint initiative of the Mediation Support Team of the Center for Security Studies ETH Zurich (CSS ETH Zurich) and the Thematic Area of Religion, Politics and Conflicts of the Human Security Division of the Swiss Federal Department of Foreign Affairs (FDFA). #### **Our approach**

Our vision is to contribute to conflict transformation processes that lead to mutually acceptable outcomes and co-existence between actors with different worldviews.

Inspired by Linda Woodhead, CARIM understands religion as a multi-dimensional phenomenon that includes the way religion provides orientation to a community, shaping how a community envisages its place and action in political life. Religion may also refer to the ways people live their faiths, the stories they inherit and share, their spiritual experiences, the leaders that guide these communities, and the related institutions and power relations.

We promote a non-judgmental, culture- and gender-sensitive approach to the role of religion in conflict. CARIM understands mediation as a process that brings conflict actors together to reach a mutually acceptable outcome. It requires the consent of the parties, is supported by an impartial third party, and is guided by a shared vision.

## What we do

### Process Support

We offer direct support to local peace-builders, actors in conflict contexts and international third parties working on conflicts where there is an interplay between religion and politics. We support the design and facilitation of dialogue processes, conflict analysis, and strategy and program development. Our outreach events sensitize policy-makers and peace practitioners to the role of religion in conflict.
