Foreword

Russia's war in Ukraine, which began on February 24, 2022, dominated national and international security policy debates last year. The Russian invasion of Ukraine has already claimed thousands of lives, and the destruction of the country by military escalation is massive. On a political level, the war also has profound consequences for Europe and international relations: Defense, security and foreign policy, NATO, the system of nuclear control and cooperation between states are confronted with new realities. These implications for the security architecture also affect Switzerland, which is located in the heart of Europe.

An important focus of the CSS' work has therefore been to analyze and classify the current situation, its medium- and long-term implications, and to develop recommendations for the strategic direction and further development of Swiss foreign, security, and defense policy.

At the same time, the consequences of the rival interests of the great powers have continued to intensify. Geopolitical conflicts, the competition for technological supremacy – especially between the United States and China – as well as the uncertainties in global supply chains that became apparent not least during the Coronavirus Pandemic and the upheavals on the Asian continent in view of China's rise pose enormous challenges for the international community.

The articles in the CSS' annual publications have therefore addressed these important issues and changes in depth. The "Bulletin 2022 on Swiss Security Policy" focused, among other things, on Switzerland's cooperation with its partner states in the field of security and defense policy, the military use of drones, and the priorities of Switzerland's UN Security Council membership.

The authors of the publication series "Strategic Trends" focused on relations between China and Russia, hypersonic technology as a political instrument in great power competition, the future of the nuclear arms control regime, and the reorganization of the "Indo-Pacific".

This year, the annual "Studie Sicherheit" conducted a follow-up survey in response to the war in Ukraine to assess, among other things, the impact on neutrality as a guiding political principle in Switzerland.

This annual report provides an overview of our activities and is intended to encourage reading of our publications. Our publications are available online on our website <u>www.css.ethz.ch</u>. Russia's War in Ukraine

On February 24, 2022, the Russian attack on Ukraine began. Armed Russian troops invaded Ukrainian territory across the country's borders. Since then, the Ukrainian army has been fighting against the Russian invaders. CSS Researchers helped to frame the situation with contributions to national and international media, background analysis, publications and CSS dialogue platforms.

ETH Workshop on Security Policy: "The Impact of the War in Ukraine".

On June 3, 2022, the CSS hosted an ETH Workshop on "The Impact of the War in Ukraine". High-level panels discussed the dynamics of war and conflict management, the medium- and long-term global and regional impacts, and the implications for Swiss security and defense policy.

Publications

In numerous CSS Analyses and Policy Perspectives, CSS Researchers have analyzed the global implications of the Russian war in Ukraine. Contributions to the Bulletin on Swiss Security Policy and Strategic Trends 2022 have also taken a closer look at the consequences of this military confrontation.



Media Contributions

CSS Researchers' analysis, commentary, and interviews on Russia's war in Ukraine in 2022 have been featured in national and international media nearly 500 times.



Contributions to the Further Development of Swiss Foreign, Security and Defense Policy

With a series of publications and various activities in the field of policy advice, the CSS made significant contributions and valuable inputs to the further development of Swiss foreign, security and defense policy in 2022.

Capability Message: Planning Scenarios and Variants of the Orientation of the Armed Forces

CSS Director Andreas Wenger advised and supported the Chief of the Armed Forces, Lieutenant General Thomas Süssli, and his staff in the development of the capability message with his expertise in several briefings and meetings.

CSS Briefing Paper: Switzerland's Security and Defense Cooperation in Europe: Possibilities for Expanded Cooperation

At the request of the DDPS, CSS Researchers wrote a CSS Briefing Paper that impacted the supplementary report to the Federal Council's Security Policy Report. This supplementary report was published on September 7, 2022. CSS Director Andreas Wenger participated as an expert in a hearing on the 2021 Security Policy Report before the Security Policy Commission of the National Council (SiK-N) on January 17, 2022, and presented the CSS Briefing Paper to the Security Policy Commission of the Council of States (SiK-S) on October 24, 2022.

Evaluation of the Crisis Management of the Canton of Graubünden in the Coronavirus Pandemic

On June 24, 2022, the CSS hosted an ETH Workshop on "The Future of Swiss Crisis Management". Four high-level panels discussed the role of the Confederation in Switzerland's crisis management, cantonal crisis management, international cooperation in crisis management, and the topic of science and crisis management. On September 8, 2022, the CSS Risk and Resilience Report of the same name was published. The focus of the evaluation is on the further development of the cantonal crisis organization regarding the entire spectrum of hazards in the canton as well as cantonal cooperation with the federal authorities and other cantons.

ICRC Course Series

The CSS Cybersecurity Team has developed a full-week course for 15 staff members from the International Commitee of the Red Cross (ICRC) and other humanitarian organizations on "Cybersecurity policy, geopolitics, and strategy". The course covers cybersecurity topics relevant to security policy, including what capabilities military actors have, the role of intelligence agencies, how political attribution works, and what international norms exist in cyberspace. In 2022, the course has been successfully held twice at ETH Zurich, and will continue to be held in 2023. As part of the "EPFL/ETHZ/ICRC Engineering Humanitarian Aid Partnership", the course aims to improve the impact of humanitarian actors by promoting specific knowledge and skills.

The IT Army of Ukraine

The IT Army of Ukraine was created ad hoc and without a clearly structured or proven plan. Born out of necessity, the IT Army has subsequently evolved into a hybrid construct that is neither civilian nor military, neither public nor private, neither local nor international, and neither lawful nor unlawful. This CSS Cyberdefense Report by Stefan Soesanto

provides the first comprehensive analysis of the structure, missions, and ecosystem of the IT Army.

The article has been downloaded nearly 20,000 times and remains the No. 1 hit on Google in a search for "IT Army". It has been picked up by national and international media and has attracted government-level attention, including the German, French and Dutch Cyber Command and various ministries of defense and foreign affairs, among others.

"Maintaining rule-based orders and respecting international law are fundamental for Switzerland." Interview with President of the Swiss Confederation Ignazio Cassis

In an interview for the Bulletin on Swiss Security Policy 2022, President of the Swiss Confederation Ignazio Cassis talks about the changing European security architecture in an increasingly multipolar world, increased security cooperation between Switzerland and the EU and NATO, and the role of the Organization for Security and Cooperation (OSCE) and the UN. While the OSCE, according to Cassis, can currently hardly fulfill its role due to Russian aggression, the UN Security Council continues to function. Accordingly, Cassis is positive about Swiss membership in the Security Council for 2023 to 2024. He sees this mandate as an opportunity to bring Swiss strengths to bear and, in the process, make an important contribution to ensuring that the Security Council remains as capable of action as possible, even in times of heightened geopolitical tensions.

Journal Article: The War in Ukraine and Global Nuclear Order

Russia's invasion of Ukraine has neither exposed the international system of nuclear control as toothless, nor brought it to the brink of collapse. The history of the global nuclear order shows how resilient it is in the face of unscrupulous actions by great powers. Alexander Bollfrass and Stephen Herzog argue that nuclear targeting, threats to deter, and related efforts to mitigate risk are hardly new phenomena. Rather, the consequence of war has been to raise public awareness of the often unpalatable role nuclear weapons play in international politics.

New Technologies: Geopolitics and Governance

The geopolitical dimension of new technologies, their applications in the military sphere, and the resulting governance challenges form a core theme of the CSS' work. The focus is on the use of geo-economic instruments in the competition of great powers for technological supremacy, the increasing importance of non-state actors in security policy, the influence of new technologies on warfare, and their limitation by possible state prohibitions of certain military applications.

In June 2022, Sophie-Charlotte Fischer gave a presentation on the geopolitical dimension of technology supply chains at a workshop of the AVIS Process. The Asian Order in Transition

Against the backdrop of China's rise, Asia is increasingly gaining political, economic, and military influence. CSS Researchers analyze how the regional order in Asia is changing because of the "Indo-Pacific" concept promoted by Japan, Australia, the United States, and India. The focus is on the associated competition between the U.S. and China, the closer cooperation between Beijing and Moscow, India's rise in importance, and the challenges and opportunities for smaller and medium-sized Asian states.

At the State-of-Asia conference of Asia Society Switzerland, Boas Lieberherr spoke about the diverging views on the concept of rule-based order. In the conceptual ambiguity could be the benefit of the concept from the point of view of the proponents. It remains unclear whether this will lead to a better common understanding of the central rules, norms, and institutions of the future international order.

Indo-Pacific: The Reconstruction of a Region in: Strategic Trends 2022

Boas Lieberherr and Linda Maduz discuss the extent to which the Indo-Pacific represents a new conceptualization of Asia. The Indian Ocean region and the Asia-Pacific are understood as a coherent strategic space. They show that the transition from the previously used "Asia-Pacific" to the "Indo-Pacific" is associated with four trends: the shift from an economic to a security agenda, from bottom-up to top-down regionalism, from multilateralism to minilateralism, and from the inclusion to the exclusion of China.

The CSS aims to study, develop, and promote effective forms of mediation in armed conflicts. The focus is on mediation support in peace processes, mediation in conflicts with a religious nature, and ceasefires in peace processes. Further, the role of local mediators, gender perspectives, the issue of environment and peace, and peacebuilding in fragile contexts are explored.

And what cyber activities can we expect in the coming months? These and other questions were discussed in the workshop organized by the European Cyber Conflict Research Initiative in Tallinn. The results are summarized in a report by Monica Kaminska, James Shires, and CSS Researcher Max Smeets.



Over the past decade, numerous states have declared cyberspace a new area of warfare. They sought to develop a military cyber strategy and establish a cyber command. No Shortcuts provides a level-headed overview of where we are in the militarization of cyberspace. In this book, CSS Researcher Max Smeets bridges the gap between technology and policy to assess the necessary building blocks for states to develop military cyber capabilities. He argues that for many states, the barriers to entry into conflict in cyberspace are currently too high. Accompanied by a variety of empirical examples, Max Smeets shows why state capabilities to develop military cyber capabilities might change over time and explains the limitations of capability transfer by states and private actors.

Conventional wisdom in security studies holds that drones have revolutionary implications for war and world politics. In this article, Antonio Calcara, Andrea Gilli, CSS Researcher Mauro Gilli, Raffaele Marchetti, and Ivan Zaccagnini challenge this theory by analyzing three conflicts in which drones have been used on a large scale. They conclude that drones per se do not have the revolutionary impact that many attribute to them.

Research Project Remote Monitoring of Armed Conflicts: Strengthening early warning capacities in armed conflicts through AI

The Remote Monitoring of Armed Conflicts (RMAC) project aims to automatically detect conflict-related events using a combination of open-source satellite images and machine learning. The goal is to facilitate better humanitarian responses from organizations working in armed conflicts. These organizations currently identify, verify, and document conflict-related events manually using satellite images. However, due to their labor-intensive nature, these processes can only be done on an ad-hoc basis. By combining open-source satellite images with machine learning, the RMAC project has the potential to automate these processes, thereby enabling organizations to monitor conflicts more systematically and supporting humanitarian responses to conflicts worldwide. The project is a collaboration between the EcoVision Lab, the Center for Security Studies, the International Committee of the Red Cross, UNDPPA, and AAAS and will run from 2022 to 2026.

Research Project Ceasefire Projekt: Introducing the ETH/PRIO Civil Conflict Ceasefire Dataset

The project builds on an ongoing collaboration between researchers at the Center for Security Studies (CSS) at ETH Zurich, the Peace Research Institute Oslo (PRIO), and Uppsala University. It is generously funded by the Folke Bernadotte Academy (FBA), the Norwegian Ministry of Foreign Affairs, and the Swedish Research Council.

An important contribution of the project was the creation of the ETH/PRIO Civil Conflict CeaseFire (CF) dataset. This contains information on all ceasefires during civil wars between 1989 and 2021, and is the first global comparative database on ceasefires in civil wars that contains information on the entire family of ceasefires, including unilateral, verbal, written, and unimplemented ceasefires. It also includes information on the purpose, timing, and nature of the ceasefire. The dataset is compatible with other conflict datasets, particularly the UCDP conflict database. It was featured in a 2022 article in the Journal of Conflict Resolution.



CSS Think Tank





Bulletin 2022 on Swiss Security Policy

The Bulletin 2022 on Swiss Security Policy once again deals with current topics of Swiss foreign and security policy. It opens with an interview with the President of the Swiss Confederation and Head of the Federal Department of Foreign Affairs (FDFA), Ignazio Cassis. The authors take a forward-thinking look at military drone use, Switzerland's security and defense policy cooperation in the shadow of Russia's war in Ukraine, priorities for Swiss UN Security Council membership, the cross-connections between peace mediation and climate protection, and the role of technology in ceasefire monitoring.



Switzerland's Security and Defense Cooperation in the Shadow of Russia's War in Ukraine

In this article, Amos Dossi and Sophie-Charlotte Fischer examine the possible implications of the Ukraine war for Swiss cooperation strategies in the security and defense sector. While Switzerland has established a close-meshed and institutionally strong network of multilateral relations in the field of European domestic security policy since the 1990s, it limited its defense cooperation to the military policy working level, relying primarily on bilateral and minilateral formats. This model worked well for a long time; however, the changed security situation and adjustments on the part of partner states suggest further development and diversification here.

Military Drone Use: Experiences, Technology and Swiss Options

In this article, Constant Despont, Dominika Kunertova and Niklas Masuhr discuss the military use of drones, which have become an indispensable part of military operations. At the same time, however, it would be an exaggeration to speak of a military revolution caused by drones. Given the offensive potential of increasing autonomy of the systems, no purely technological solution to drone defense can be expected in the foreseeable future. Accordingly, Despont, Kunertova and Masuhr argue regarding Switzerland that drones are and will remain a task for the whole state.

Priorities of Swiss UN Security Council Membership

In this article, Fabien Merz highlights the opportunities and ambitions associated with the four thematic priorities of Swiss Security Council membership for the period 2023–2024. He shows what Switzerland has to offer in the areas of promoting sustainable peace, protecting civilians, climate security, and increasing the Council's efficiency. He argues that Switzerland's foreign policy profile puts it in a good position to offer added value in these areas and to contribute constructively to the Council.

Strategic Trends 2022

The Strategic Trends publication series offers an annual analysis of important world political developments. The focus is on issues of international security. The volumes contain in-depth studies of selected key trends and are enriched with numerous graphics. The series is published in English.

The chapters in this year's volume address important trends in world politics at a time of rapid change and great uncertainty. The authors have looked at events up to April 1, knowing full well that the situation may change significantly by the time the volume is scheduled for publication in May. Nonetheless, the four chapters address key strategic trends that will shape international security in the years ahead, regardless of the outcome of the Russian war in Ukraine.



China-Russia Relations and Asian Security

In the first chapter, Brian Carlson analyzes China-Russia relations and the implications for Asian security.

Hypersonic Weapons: Emerging, Disruptive, Political

In the second chapter, Dominika Kunertova explains how hypersonic technology has become a political tool in the great power competition between the United States, China, and Russia.

Transatlantic Security and the Future of Nuclear Arms Control

In the third chapter, Névine Schepers argues that Russia's war in Ukraine significantly complicates nuclear arms control efforts, while underscoring their necessity given the increased risk of nuclear escalation.

Indo-Pacific: The Reconstruction of a Region

In the concluding chapter, Boas Lieberherr and Linda Maduz analyze the emerging concept of the Indo-Pacific, particularly with regard to its strategic implications.

On May 13, 2022, the CSS, on the occasion of the publication "Strategic Trends 2022", invited to the ETH conference "World Political Situation 2022". Two selected articles were published in short form on the same day on a double page of the Neue Zürcher Zeitung. The first article was about the Indo-Pacific. This is a relatively new regional framework driven primarily by the United States, Australia, India and Japan. East Asia, the Pacific region, and the Indian Ocean are seen as one strategically connected area. The second text focused on the future of arms control. In view of new nuclear dynamics – not least in the light of Russian nuclear threats in the context of Moscow's invasion of Ukraine – it was more important than ever before. In view of difficult political and technological contexts, however, it is not easy to give arms control the importance it deserves.



The annual study "Sicherheit", which is published jointly by the Military Academy at ETH Zurich (MILAC) and the CSS, serves to identify long-term trends in the formation of opinion on foreign, security and defense policy in Switzerland.

In January 2022, the Swiss continue to feel very secure and remain united and almost unanimous in their support for neutrality. In terms of foreign policy, the Swiss electorate's low willingness to open up continues. Respondents continue to have a positive attitude toward the Swiss Army. Compared to 2018, support for a mandatory orientation day for women has declined. However, a majority tends to be in favor. The data for the "Sicherheit 2022" study was collected between January 4 and 20, 2022. Due to the war in Ukraine, a follow-up survey was conducted this year.

With the war in Ukraine, Swiss people are taking a more pessimistic view of the future. The war is leading to a more critical view of Swiss neutrality. At the same time, security policy cooperation with NATO or the EU is becoming more popular. In addition, Swiss people want to strengthen Switzerland's defense capabilities. Therefore, good training and equipment of the army are demanded. This is shown by the results of the follow-up survey of the "Sicherheit 2022" study. The follow-up survey took place at the beginning of June 2022.

Michael Singh, Lane-Swig Senior Fellow and Managing Director at the Washington Institute and former Senior Director for Middle East Affairs at the National Security Council presented his views on US policy in the Middle East considering current challenges in the Middle East, such as the rapprochement between Israel and certain Arab countries or Iran's influence on regional security and Tehran's nuclear program. ■ ETH Evening Talk: "Great Power **Conflicts and Domestic Security: The** Importance of Critical Supply Chains" As part of the ETH Evening Talks event series, the Center for Security Studies (CSS) invited Prof. Dr. Heribert Dieter, researcher at the Stiftung für Wissenschaft und Politik in Berlin and adjunct professor at the University of Potsdam, and Dr. Sophie-Charlotte Fischer, CSS Researcher in the Swiss and Euro-Atlantic Security Team, on September 28, 2022, to shed light on the U.S.-China global conflict from a political economy as well as security policy perspective. They focused primarily on the role of critical supply chains.

ETH Lecture Event: "The Consequences of the Russian Invasion of Ukraine for European Security"

On November 10, 2022, at the invitation of the Center for Security Studies (CSS), Ambassador (ret.) Dr. Christoph Heusgen, Chairman of the Munich Security Conference, spoke about the implications of the Russian war in Ukraine for European security policy. According to Ambassador Heusgen, an important question is whether Europe has the capacity to stand together and cooperate militarily in conflicts on or at the edge of the continent. He stressed several times that the West must continue to support Ukraine, even though high (and rising) energy prices, inflation, and the upcoming recession are causing more and more people to critically question the support for Ukraine.

One, Two, or Two Hundred Internets?: The Politics of Future Internet Architectures

The Internet has grown massively since its commercialization and globalization in the 1990s. Yet, despite its success, the notion that the Internet could lose its global character looms large. The debate plays out in two variants. In the first, the Internet is evolving into a "splinternet" made up of multiple national Internets due to intentional access and connectivity restrictions imposed by governments. A second assertion that emerged with the onset of the U.S.-China "trade war" in 2018 is that we are moving toward a bifurcation between a Western and a Chinese Internet. This CSS Cyberdefense Report provides an overview of the discourse on the fragmentation and bifurcation of the Internet.

Swiss Security and Defense Cooperation in Europe: Options for Further Development CSS Briefing Paper, 2022

The Russian war against Ukraine has shaken the foundations of the European security order that has evolved since 1989. European states are placing new priority on strengthening their military preparedness as well as their economic and social resilience. NATO is experiencing a renaissance as part of these efforts - see the accession of Sweden and Finland - and the EU, too, seems to be adapting its political priorities to the new situation. These upheavals affect the planning bases of Swiss security and defense policy in a variety of incisive ways. One important aspect is multilateral security and defense cooperation. On behalf of the Federal Department of Defense, Civil Protection and Sport (DDPS), CSS has prepared a briefing paper. It shows how Switzerland can position itself actively and expediently in this increasingly important area of intergovernmental cooperation.

Course for Higher Cadres of the Swiss Security Network (LG SVS II / 2022)

On August 31, 2022, Prof. Andreas Wenger gave the opening lecture followed by a discussion at the SSN senior management course in Bern on "Switzer-land's security policy in a historical perspective". ■

4+4 Discussion on Drones

On August 25, 2022, a 4+4 discussion on drones took place with representatives of the DDPS Defense Group, in which Prof. Andreas Wenger, Niklas Masuhr, Dr. Dominika Kunertova and Constant Despont participated on behalf of the CSS. The CSS provided substantive inputs on military drones, operational empirics, technology, and Swiss options in the field of drones against the backdrop of the Armed Forces' priorities, among other topics. Future contributions of the CSS, as well as the cooperation with the Swiss Drone and Robotics Center (SDRZ VBS) in Thun were also discussed.

Autumn seminar with the management of the Federal Office for Civil Protection FOCP

At the invitation of FOCP Director Dr. Michaela Schärer, CSS Director Prof. Andreas Wenger participated as an external expert in a high-level workshop on strategic issues with the FOCP Executive Board on October 20, 2022.

DDPS Workshop on "Information Warfare"

Lennart Maschmeyer gave a presentation on the topic of influence activities and disinformation as an external expert at a workshop organized by the DDPS with high-ranking representatives from the General Secretariat of the DDPS, the Defense Group, the Federal Armaments Agency armasuisse, the Federal Intelligence Service and the Federal Office for Civil Protection.

Cyber Ceasefires

On October 10–11, 2022, mediation, ceasefire, and cyber experts met in Zurich to discuss how best to integrate offensive cyber capabilities into peace processes. It was the first meeting on this topic and was co-sponsored by the United Nations Mediation Support Unit and the CSS. The workshop further developed ideas first presented in the CSS publication "Cyber Ceasefires". The findings will inform new UN guidelines next year. ■

Contributions to SCHWEIZ 2035: Lage- und Umfeldanalyse at the request of the Federal Chancellery:

Two CSS contributions were presented as part of the book publication "Schweiz 2035: Think Tanks beantworten 20 Zukunftsfragen" on May 25, 2022:

1 Will Switzerland have to fend off a cyberattack from another country on its critical infrastructures by 2035?

Digitization, networking and the increasing complexity of IT offer cyber attackers opportunities to sabotage functional processes of critical infrastructures and thus, if necessary, also to exert political pressure. Dr. Myriam Dunn Cavelty and CSS Director Prof. Andreas Wenger expect more cyberattacks on critical infrastructure by 2035. They write in their article that these are unlikely to be destructive attacks of a warlike nature, however, but rather espionage activities or small acts of sabotage.

2 Will Switzerland still be neutral in 2035?

As international relations continue to develop, the question increasingly arises as to whether it will still be possible for Switzerland to remain neutral in the future. According to CSS Director Prof. Andreas Wenger and CSS Think Tank Head Dr. Oliver Thränert, it will still be so in 2035. They explain the various functions of neutrality and classify the role of the concept in the current and future context of globalization and great power rivalries.

Blending Homegrown Peacebuilding Solutions to Overcome Protracted Pastoral Conflicts in Africa: Experience-sharing workshop for the East and Southern Africa Region

This workshop with mediation and peace practitioners from Kenya, Zimbabwe, Somalia, and South Sudan took place in Nairobi, Kenya, November 22–24, 2022, and was co-organized by the Mediation Support Project (CSS and swisspeace, funded by the FDFA) with the Swiss Embassy in Kenya, Garissa University and the Frontier Counties Development

Council. "Mediation and Governance in Fragile Contexts: Small Steps to Peace" was launched and brought together representatives of governments and civil society working at the global, regional, and local levels to develop and achieve Sustainable Development Goal 16 (promote peace, inclusiveness and end violence). Participants reflected on and improved their mediation and peacebuilding practices and explored how Dekha Ibrahim Abdi's insights on mediation and peacebuilding can be applied to current challenges. ■



Islamic Scholars Shape the Behavior of Armed Groups

A webinar on "The Role of Islamic Jurists in Shaping Armed Group Behavior" in the context of conflict, negotiation, and governance activities was organized on February 1, 2022, by Culture and Religion in Mediation (CARIM, a joint program of the CSS and the FDFA) in partnership with the Cordoba Peace Institute (CPI). Fifty experts, government representatives, and peace practitioners from the UN, EU, Switzerland, Africa, and MENA gathered to discuss the preliminary findings of a pilot study of cases from Mali, Syria, and Iraq conducted by the CPI with support from the Templeton Charity Foundation Switzerland and the FDFA.

Peace Mediation Course

From July 3–15, 2022, the annual Peace Mediation Course took place in Saanen, Switzerland. The course once again brought together top-notch trainers and 25 motivated practitioners to deepen their understanding of peace mediation and acquire the necessary skills and knowledge to effectively support mediation processes. The course is offered by the Federal Department of Foreign Affairs (FDFA) and organized jointly with the Mediation Support Project (CSS and swisspeace, funded by the FDFA).

Workshop on Dialogue in Kenya

Dialogue and trust are key to sustainable peace. In 2022, the Culture and Religion in Mediation (CARIM) program, a joint program of the CSS and the FDFA, held several meetings in Kenya with the Swiss Embassy and UNDP to discuss the importance of and support for inclusive, locally led, and community-driven dialogues.







BA ETH in Political Science

The six-semester bachelor's degree program BA Governmental Sciences is aimed at prospective Swiss professional officers. It comprises a curriculum of humanities, social and political science subjects, which are supplemented with military science courses. The program is a collaboration between the Department of Humanities, Social and Political Sciences (D-GESS) at ETH Zurich and the Military Academy (MILAK) at ETH Zurich. The students are at the same time graduates of the Bachelor Course (BLG) at MILAK.

Master of Arts in Comparative and International Studies (MACIS)

MACIS is a four-semester research-oriented graduate program of the Center for Comparative and International Studies (CIS). The MACIS curriculum combines comparative and international political science to teach students about the complex interrelationships between national, international, and transnational political processes. Special emphasis is placed on methods, theories, and research-oriented work. In this respect, the MACIS also sees itself as preparation for the doctoral level. Of the national and international applicants, about 20 students can be accepted each year.

Science in Perspective / Science in Context

With the course program Science in Perspective / Wissenschaft im Kontext, the D-GESS enables students at ETH Zurich to gain new perspectives on the content of their core subjects. SiP thus enriches studies at ETH Zurich and contributes to the university's unique profile. Various CSS staff members teach in this course program. In the lectures, political contexts are conveyed without which science and technology would be inconceivable. The aim is to empower students to recognize and critically question connections between scientific knowledge, technical innovations, cultural contexts, individuals, and societies. In this way, they expand their reflective competence and are prepared for societal and global developments of the future.

CIS Doctoral Program

The Center for Comparative and International Studies (CIS) offers different ways to complete a doctoral program. The 12 ECTS doctorates of the Department of Humanities, Social and State Sciences (D-GESS) at ETH Zurich specialize in one of the five core research topics – Democracy, Market and Politics, Political Violence, Sustainable Development, and Security. It is possible to pursue a subject-specific or cross-disciplinary doctorate. The subject-specific doctorate is intended for candidates who have completed a master's degree in a subject area of a D-GESS professorship. (e.g. law, history, philosophy, political science, sociology, economics). The Master's degree should have a similar focus as the doctorate. The cross-disciplinary D-GESS doctorate is recommended for candidates who have obtained a Master of Science (MSc) in natural or technical sciences from ETH Zurich or another university. The D-GESS doctorate requires cooperation with another ETH department – e.g. in the form of co-referees from the natural or technical sciences of ETH Zurich.

Master of Advanced Studies ETH Mediation in Peace Processes (MAS ETH MPP)

The CSS supports the Master of Advanced Studies ETH Mediation in Peace Processes. This program provides participants with the necessary knowledge, skills, and techniques to mediate in violent political conflicts. The MAS ETH MPP is currently the only MAS program for mediation in peace processes.

The MAS ETH MPP is based on a close partnership between ETH Zurich, the Swiss Federal Department of Foreign Affairs (FDFA) and the foreign ministries of Germany and Finland. The program is also supported by international organizations such as the UN, the EU and the Organization for Security and Cooperation in Europe (OSCE).

In 2022, a total of three modules were conducted. Module 2 "Mediation Methods – Negotiation/Mediation Theories and Skills" in March provided students with the core concepts and techniques of negotiation and mediation. In June, Module 3 "Mediation Content – Substance of Peace Processes and Peace Agreements" highlighted five key issues such as security, justice, power sharing, economics and the environment from a peace mediation perspective. Module 4, "Mediation Process Design – Models, Theory, and Practice", in November addressed key elements of process design such as inclusion, negotiation venue, mediation style, and mandate. In addition, the MAS ETH MPP program continued its "Mediation Exchanges" series of events open exclusively to the program's community of practice (i.e., current and former students, strategic partners, and the CSS). The following events were offered virtually:

- > 1/2022 "Environmental Cooperation to Promote Peace in the Middle East" with ECOPEACE, a trilateral Jordanian, Palestinian and Israeli environmental peacebuilding organization.
- > 2/2022 "The War in Ukraine: Geopolitics and Prospects for Peace" with mediation and dialogue expert (and MAS ETH MPP lecturer) Denis Matveev, Dr. Christina Horváth Stenner, Mediation Support Officer at the OSCE in Vienna and MAS ETH MPP graduate, and Benno Zogg, former Senior Researcher and Head of the Swiss and Euro-Atlantic Security Team at CSS.
- 3/2022 "The Conflict in Myanmar: Narratives, International Norms, and Prospects for Peace" with Emma Leslie, founder of the Centre for Peace and Conflict Studies in Cambodia.

Panel MAS ETH MPP Policy Forum (Heidi Hostettler)

In June 2022, the MAS ETH MPP program held its first Alumni Meeting as part of the Strategic Advisory Board and Policy Forum meeting on "Innovating Peace Mediation: New Approaches and Strategies". The event featured working groups on four major macro trends in armed conflict (geopolitics, worldviews, technology, and environment) and their implications for professionalizing peace mediation, and concluded with a high-level panel discussion. The alumni meeting brought together current MAS ETH MPP students and alumni from the two previous cycles to explore various case studies presented by participants, as well as mediation research and skills. The main results of the Policy Forum discussions were summarized in a report: <u>Online version</u>. In each case, insights are provided on the general implications of the field for armed conflict and peace mediation and on possible innovations. A reading list and a list of innovations for



peace mediation, as well as a brief description of the Policy Forum methodology and participants, are also included.

DAS ETH in Military Science

The two-semester continuing education program Diploma of Advanced Studies ETH in Military Science (DAS MILWISS) is aimed at prospective professional officers who already have a university degree or equivalent qualification. Admitted are Swiss, but also representatives of friendly foreign armies who were simultaneously accepted into the Diploma Course of the Military Academy (MILAK) at the ETH Zurich (DLG). The DAS MILWISS program is accredited at the ETH School for Continuing Education and includes selected military science subjects supplemented by security policy. It is run in collaboration between the Department of Humanities, Social and Political Sciences (D-GESS) at ETH Zurich and MILAK.

On March 15, 2023, 35 graduates of the bachelor's degree program (BSG19) and the diploma program (DAS21) of the Military Academy were graduated at ETH. For the first time since 2020, the graduation ceremony could again take place in the usual setting at ETH. In the presence of numerous invited guests as well as family members and friends, the graduates were bid farewell in a festive setting and were able to receive their diplomas as federally certified professional officers at the Audi Max.

CAS / DAS ETH in Cyber Security

This program takes a multidisciplinary approach that examines both technical and strategic policy aspects of information and cybersecurity. In addition to an introduction to the subject and a seminar on a current cybersecurity topic, lecturers from the Department D-GESS offer a course on political, strategic, governmental and military aspects of cybersecurity.

CSS employees taught in three courses during the 2022 Fall Semester:

- Realities of Cyber Conflict (Max Smeets)
- Perceptions of Cyber Conflict (Miguel Gomez)
- Attribution (Max Smeets)

NADEL Center for Development and Cooperation

The NADEL Center for Development and Cooperation combines empirical social science research with an interdisciplinary teaching program and various transfer programs for practitioners, pursuing the goal of contributing to effective and sustainable development cooperation.

The CSS cooperates with the NADEL on two courses, both of which took place in 2022:

- Mediation Process Design Supporting Dialogue and Negotiation
- Fragile Contexts The Nexus between Humanitarian Aid, Peace and Development

About the Center for Security Studies (CSS)

The CSS is committed to researching Swiss and international security issues. Its activities are structured into the pillars of research, teaching, and think tank. The CSS was founded in 1986 by Prof. em. Dr. Kurt R. Spillmann and has developed into a national center of competence for security policy with an international impact. Its work is independent, of practical relevance, and based on solid academic inquiry. The CSS combines research with policy consultancy to bridge the gap between academia and practice. It trains highly qualified young talents and serves as a point of contact and source of information for the interested public.

Management, employees

Since 2002, the CSS has been headed by Prof. Dr. Andreas Wenger. He is professor for Swiss and International Security Policy at ETH Zurich and program director of the MAS ETH Mediation in Peace Processes. The CSS employs a total of about 60 staff members.

Partner network

The CSS has a large network of national and international partners from academia, administration, policy, the media, and the private sector. ■

CSS Internship

Each year, CSS offers six-week internships for four students from master's or bachelor's programs who are in their final year of study.

National Task

Since 2021, the CSS represents an openended national task transferred to the ETH Domain by the Federal Council. Already since 2004, the CSS of ETH Zurich has maintained a strategic partnership with the Federal Department of Defense, Civil Protection and Sport (DDPS). This was followed in 2012 by a further partnership with the Federal Department of Foreign Affairs (FDFA). The advisory boards, made up of representatives of the respective sponsoring bodies, support the CSS management in the strategic orientation of the center. The CSS is located in the Department of Humanities. Social and Political Sciences (D-GESS) at ETH Zurich. Together with the political science professorships of ETH Zurich and the University of Zurich, it has formed the Center for Comparative and International Studies (CIS) since 1997.

Alumni

Former employees of the CSS are organized in the Alumni Fachgruppe CSS of the ETH Alumni. In addition to a wide range of benefits, they also receive regular information from the ETH Alumni Association and, in particular, invitations to selected CSS events.
