- All other categories don't belong to the Learning Agreement. If you add them, the Learning Agreement will be rejected.
- Interdisciplinary Electives: You must decide for *one* <u>specific area</u> and attend at least two courses worth at least 8 credits within this area. Courses from other area/s must be listed in the category Additional Electives.
- Submit only a completely filled-in Learning Agreement.
- You can change the Learning Agreement during your studies.
